amending special Rules for the A.P.E.S. in the matter of
recruitment by transfer of Junior Lecturers as Lecturers
under Category-2 of Class-IV of the A.P.E.S.

In G.O.2nd read above, Government have extended the
Revised U.G.C.Scales of 1996 to the Lecturers working in
Government Degree Colleges. As per these orders, recruitment
to the posts of Lecturers shall be made on merit through an
eligibility test (NET). The candidates fulfilling the
minimum academic qualifications prescribed to the post of
post of Lecturers.

In G.O.3rd read above, Government have issued orders
